# The 15<sup>th</sup> edition of the CEE TOP 500 –

Despite initial concerns about the impact of the Ukraine war on Central and Eastern European (CEE) economies, the region has demonstrated resilience. However, due to the energy crisis and rising costs, the region has been experiencing a gradual slowdown.



Slower economic growth, volatility in commodity markets, tight labour markets and high inflation are among the key risk factors impacting the business environment and consumer behaviour in CEE. The region's 500 largest companies displayed resilience and adaptability and recorded soaring revenues and higher profits in 2022.

# A WORD FROM JAROSŁAW JAWORSKI

I would like to extend a warm welcome as we introduce you to the CEE Top 500 ranking, our annual publication highlighting the largest companies operating in the Central and Eastern European region (CEE). Published for the 15th year in a row, this analysis is widely acknowledged by the market as a crucial resource for enterprises with a presence in or connection to CEE.

As every year, the publication reflects the region's economic activity of the previous year and also provides an outlook. In this latest edition of the CEE Top 500 study, we bear witness to the remarkable resilience of the companies in CEE in the face of significant challenges.

Operating a business in Central and Eastern Europe over recent years has presented substantial challenges. The initial shock of the COVID-19 pandemic severely disrupted supply chains and distorted customer demand. Then, Russia invaded Ukraine, which led to a surge in energy prices, reaching nearly record levels, and supply chain disruptions. Moreover, inflation and interest rates have both experienced sharp increases while labour shortages continue to be an issue. Despite all these challenges, the CEE region has displayed unwavering strength and adaptability. While GDP growth moderated, it remained robust, rising by +4% (compared to 6.2% in the previous year).

In this study, you will discover that this macroeconomic environment, coupled with cost increases, set the stage for remarkable turnover growth among businesses. In 2022, the overall turnover of these top 500 companies surged by 39.8% to 1.1 trillion euros, reflecting substantial growth. Competition for the top positions has intensified. In our 2010 edition of the CEE Top 500 companies, the minimum revenue for a company to qualify for the ranking was 354 million euros, but this has more than doubled to 710 million euros this year.

This edition of the CEE Top 500 study provides an invaluable insight into the region's economic landscape, demonstrating its capacity to weather storms and to continue along a path to growth. I hope you enjoy reading it.

# **FADING RESILIENCE TO CHALLENGES**

Despite expectations of a prompt deterioration of Central and Eastern European economies and businesses due to the war in Ukraine, the region proved to be relatively resilient. However, as a result of the energy crisis and soaring costs, Central and Eastern Europe has been experiencing a gradual slowdown.

Although the Central and Eastern European (CEE) region was able to recover from the slump caused by the COVID-19 pandemic, various sectors failed to return to levels of business activity seen in the previous decade. Then came another challenge: Russia launched its full-scale invasion of Ukraine, triggering both humanitarian and economic crises that impacted the CEE region. The willingness to support Ukrainians affected by the war opened the borders for them to many European countries, including in the CEE region. The economic impact was felt not only as a result of the influx of refugees, but also as cost increases and shortages of various production components. Indeed, energy commodities prices soared because of Russia's status as a global producer and exporter, supplying Europe to a significant extent, while both Russia and Ukraine accounted for a large share in global exports of agricultural commodities and various metals used in production processes by many sectors, further exacerbating supply chain disruptions. Those various costs had already started increasing in 2021 as a result of the postpandemic recovery, and soared in 2022.

While new challenges increased uncertainty, only the gradual decrease in demand and soaring prices made room for relatively solid economic growth rates in the CEE countries. Average GDP growth in the CEE region reached 4.0% in 2022, which was admittedly lower than the 6.2% recorded in 2021, but still decent compared with pre-pandemic levels. CEE countries were able to use their competitive advantage and remained widely present on external markets. On the domestic side, a strong labour market with low unemployment rates and solid wage growth kept household consumption growing, especially given the support provided by social measures in a number of countries. According to Eurostat calculations, the average EU unemployment rate reached 6.2% in 2022, while it was lower in the same period in the Czech Rep. (2.2%), Poland (2.9%), Hungary (3.6%), Slovenia (4.0%), Bulgaria (4.3%), Romania (5.6%), Estonia (5.6%), Lithuania (6.0%) and Slovakia (6.1%).


Growing inventories were another component that supported solid GDP growth rates in the CEE region. As companies faced increasing operational costs, including components

and parts prices, they rushed through purchases of available inputs to avoid a further increase in their prices. As a result, inventories rose to high levels and accounted for a sizeable contribution to countries' GDP growth rates, like in Poland, where it reached almost half of total growth in the first quarter of 2022. From the current perspective, it should be concluded that lots of companies were stocked at high prices, triggering a destocking process in 2023.

The above-mentioned macroeconomic environment and the overall increase in costs were behind growing turnover figures at businesses. The results of the 2022 ranking of the region's largest companies confirmed that such entities benefited from that. The CEE Top 500 outlines the economic situation at the 500 largest companies in Central and Eastern Europe measured by turnover. Overall turnover in the top 500 companies soared by 39.8% to 1.1 trillion euros. Average turnover increased to 2,287 million euros compared to last year's 1,635 million euros. That being said, however, the battle for the top spot is getting tougher. In our 2010 edition of the CEE Top 500 companies, the minimum revenue for a company to qualify for the ranking was 354 million euros, but this has more than doubled to 710 million euros this year.

Aggregated net profits amounted to 54,745 million euros (+46.5% compared to the previous year) and employment at the 500 largest companies was 2.3 million people (+3.5%).

This study utilises Coface's online platform iCON to gather this financial data and it also provides individual company credit assessments. The Coface assessment indicates the probability of default for the company within 12 months of the date the score was set, with values ranging from 0 (insolvency/preliminary/debt regulation proceedings) to 10 (excellent risk). The average score for all 500 listed companies reflects a low risk with a value of 6.4. Only 2% have a score of 3 or less, indicating a very high risk of default. The vast majority of participants (65%) show a very strong financial basis (score of 6+). Best rated are Czech and Slovenian companies with an average of 7.0, while Estonian representatives score lowest with 4.7.

#### Three Newcomers to the Top 10

Companies at the top will already be very familiar from previous rankings. PKN Orlen remains unbeaten in the top spot, strengthening its position as its turnover soared by 111% after increasing by 52% in the previous year. Czech RWE (2nd), the multinational oil and gas company MOL Hungary (3rd), Hungarian MVM Energetika (4th), Czech Skoda Auto (5th), retailer Jeronimo Polska (6th) and the Polish energy company PGE (7th) were already at the top in previous rankings. All of them recorded a higher turnover in 2022 compared to the previous year, while soaring revenues in the triple-digit range were reported by electricity trading companies such as RWE and MVM. On the other hand, automotive companies were somewhat weakly represented in the Top 10 this time. Only Skoda remained, although it lost the 2nd position it had held in the previous two years due to a mild increase in turnover of 5% in 2022. Not so much weak demand but supply challenges resulted in weak turnover for the automotive sector compared to others. Volkswagen Slovakia (11th) was pushed out of its spot in the top 10, the same having happened to Audi Hungaria (14th) in the previous ranking. Both of them had enjoyed positions in the Top 10 in past years.

Newcomers to the Top 10 include energy suppliers and traders, which were able to benefit from the market situation. Romanian OMV Petrom (8th) moved up 17 places, Bulgarian

Energy Holding (9th) advanced 6 places, while Czech OTE (10th) rose 23 places.

In terms of newcomers to the overall ranking, 82 new companies made it into the 500 largest companies this time. A year ago, there were 71 such entities. The financials of newcomers also improved in that time. While their aggregated turnover reached 75.8 billion euros (a share of 9.0% in the total turnover of all ranked companies) in the previous ranking, it grew to 111.4 billion euros (a 9.7% share) in the current one.


#### Let the stars shine - Top performers

Some companies deserve a special mention here for having outperformed their competitors and proving to have been more successful than in 2021. This group comprises mostly companies that mirrored the economic situation, i.e. it benefited from a continued surge in commodity prices. That includes companies involved in electricity trading and transmission, as well as petrochemical companies like Bulgarian TETs Maritsa Iztok 2 (139th), which moved up 256 places thanks to the increase in turnover of 199%, Croatian Petrol (263rd), which moved up 231 places, as well as the Lithuanian Ignitis UAB (80th), which moved up 214 places, and Romanian Tinmar Energy (165th), which moved up 202 places in the ranking.

**COUNTRY RANKING** 

Economic activity slowed in CEE countries, but the largest CEE companies were able to record solid financial results. Despite the challenges, turnover and profits soared, although by different amounts in the various countries.

Once again, it is Polish participants that dominated the CEE of twelve countries, were able to increase their share in the Top 500 (33.2% of all companies), then Czech (15.4%) and ranking. Poland used its diversified economic and sectoral Romanian players (12.0%). The top 3 countries are home to structure and reported the largest increase in representatives, 60.6% of all of the companies on the list. One half, i.e. six out with 13 more companies compared to the previous year.



Next, with a higher number of entities this time, were Estonia and Bulgaria (8 and 6, respectively). By contrast, Czechia and Hungary recorded the biggest decrease in the number of companies in the ranking, namely 15 and 8 companies less than the previous year, which can be partly attributed to a broad-based presence of the automotive sector in those countries.

#### And the winner is...

The number 1 spot in both the company ranking and the country ranking has been taken by **Poland** for years. The country is home to the largest businesses in the region (average turnover of 2.5 billion euros) with aggregated turnover increasing by 37.9% in 2022 compared to the previous year. Poland is the largest country in the region with the biggest number of inhabitants, i.e. a potential consumer base for companies. Polish companies remained active on both domestic and foreign markets and also benefited from being included in various supply chains at the same time.

A solid GDP growth rate of 5.3% in 2022 helped Poland add more companies to the ranking this time. 166 Polish companies are included in the current ranking, which is 13 more than previously. Aggregated revenues reached 413.2 billion euros in 2022, while net profits increased by 38.6% to 21.6 billion euros. These results still crowned the country the undisputed winner in terms of both the number of companies and the turnover generated. The average Coface Company Assessment value is 6.1, which stands below the regional average of 6.4.

Poland is the country in the ranking with the most diverse industrial structure. No single sector is dominant within the top players, although minerals, chemicals, petroleum, plastics & pharma remains the largest when it comes to turnover (27.2%), while automotive & transport accounted for the largest total number of companies (15.1%).

#### Coming second...

Despite having the biggest drop in the number of represented companies (15 entities), the **Czech Republic** was again able to take second place, the same as its previous rank. This time it is represented by a total of 77 entities (compared to 92 companies previously) with an aggregated turnover of 210 billion euros. The latter increased during the course of 2022 by 33.0%; however, net profits soared by 103.7%.

The Czech Republic is home to plenty of automotive companies, which remain a pillar of industry and account for the biggest share of the largest companies. The automotive and transport sector remains the most dominant in the ranking of Czech companies in terms of the sector's turnover (38.3 billion euros; an 18.2% share in total), while the number of companies also reached the same share of 18.2%, such as was recorded by utilities and public services (85.5 billion euros). Nearly half of the automotive and transport sector's aggregated turnover was generated by Škoda Auto alone (18.4 billion euro, +5.0%).

### The third place goes to...

Finally, the third spot on the podium goes to **Romania**, which replaced Hungary in that position thanks to 60 top players in the CEE region. Romania added just one more company over the previous ranking. The turnover of Romanian companies increased by 44.1% to 112.2 billion euros, while net profits jumped by 142.5%, beating all other countries with an increase on this scale.

Minerals, chemicals, petroleum, plastics & pharma constitute the biggest sector among the largest Romanian companies as it accounts for the biggest share in terms of generated turnover (32.0%). Then comes utilities and public services as well as non-specialised trade, with the share in turnover reaching 18.7% and 16.3%, respectively. Minerals and utilities are also sectors with the highest representation of Romanian companies in the current ranking.

#### And then there are the rest...

CEETOP 500 COMPANIES

The fourth most significant country is **Hungary** with 54 companies, i.e. ten fewer than previously. Compared to the previous year, revenues at Hungary's largest companies rose by 44.7%, while net profits increased by 13.6%. Aggregated turnover amounted to 142.4 billion euros in 2022, while the average Coface assessment reached 6.3, slightly below the CEE average. Minerals, chemicals, petroleum, plastics & pharma constitute the biggest sector among the largest Hungarian companies as it accounts for the biggest share in terms of generated turnover (24.6%). Then come electronics, information & telecommunications as well as automotive & transport, with the share in turnover reaching 18.8% and 14.5%, respectively.

Fifth place in the ranking went to **Slovakia** and **Bulgaria** ex aequo with 31 companies each. Nevertheless, Slovakian companies reported higher turnover than Bulgarian ones, namely reaching 66.3 billion euros, i.e. 26.5% more than a year ago, although profits dropped by 19.7%. Similar to its neighbour, the Czech Republic, automotive is strongly represented by the largest companies in the country (37% according to turnover and 23% according to the number of companies). Bulgaria's turnover (59 billion euros) increased by 69.9%, while net profits soared by 59.8%. Utilities and public services were the most dominant sector, with a share of 32% in terms of turnover and 39% according to the number of companies).

Further down the ranking we find **Lithuania** with 22 companies (same as previously) followed by **Slovenia** (14 companies, 1 less than previous year) and Serbia (14, +1), then **Croatia** (13, +2) and **Estonia** (13, +8); bringing up the rear is **Latvia** (5, -1). Around 12% of the total CEE Top 500 turnover comes from these countries.

Ranked Baltic and Balkan businesses are among the smallest in the region, with an average turnover of around 1.5 billion euros or even less as in the case of Estonia. Yet, they still represent the largest share in their home nations. Comparing positions in the CEE Top 500, the largest number of newcomers comes from Poland, i.e. 28 out of all 166 new entries to the ranking. The highest move up the ranking was also achieved by Polish companies (nearly 34% of all entities moved up). On the other hand, a sizeable number of companies from Poland also experienced lower positions this time, with 32% of them moving down the ranking. Next, Czech entities account for 19% of the total number of companies losing their previous positions.

Despite having the biggest drop in the number of represented companies (15 entities), the **Czech Republic** was again able to take second place in **Country Ranking**.

### **SECTOR RANKING**

The three key sectors represented by the largest companies in the region continue to account for a sizeable share of revenue generated with almost 58%. However the leading group of sectors changed this time. Soaring commodities' prices enabled the sector of utilities & public services to record a rapid acceleration in turnover and taking the second rank pushing down automotive &transport.

in turnover this time. The surge in energy prices on global markets continued and even accelerated after Russia launched surge. For this reason, the sectors of utilities & public services recorded the highest growth in turnover in 2022, namely 64.1% and 60.9% respectively. Subsequently, the prices of agricultural recording double-digit turnover growth; the only exception was the construction industry, which reported an increase of 8.1%.

#### Leading position for the oil & gas sector

The mineral chemicals, petroleum, plastics & pharma sector has traditionally been the largest in the CEE Top 500 ranking. The sector's turnover rose by 60.9% in 2022, holding on to its spot as the largest sector thanks to aggregated revenues of 272 billion euros and a total of 88 companies (18% of total). Moreover, the sector enjoyed the highest surge in net profits, namely by 100.5%. Growing turnover in the sector enabled it to increase its number of representatives by 3 entities in the current ranking compared to the previous year.

Soaring oil and natural gas prices created opportunities for generating profits from refining margins, especially considering still solid demand and despite the challenges. CEE companies in the sector mostly do business in the downstream segment, i.e. refining and processing oil and gas. It should be noted that there are not only oil & gas companies in this sector. As mentioned above, its wide coverage also includes plastics & pharma, both of which recorded relatively solid demand and rising revenues. ranking: Poland's PKN Orlen, as the largest company in the CEE region, Hungary's MOL and Romania's OMV Petrom. In the mineral chemicals, petroleum, plastics & pharma sector, 38 businesses moved up in the ranking. The average @rating score for the sector is 6.6, i.e. higher than the overall average of 6.4.

### Similar to the previous ranking, all sectors recorded an increase Utilities & public services take second


its full-scale invasion of Ukraine. That made it possible for the The sector of utilities & public services moved up from fourth to turnover of companies producing and trading in energy to second place thanks to the unusual acceleration of revenues in the macroeconomic environment described above. Compared as well as minerals, chemicals, petroleum, plastics & pharma to the year before, it was able to increase the number of representatives in the current ranking by 15, making it the biggest rise among all sectors. Furthermore, the sector made commodities and various other inputs also soared, with all sectors an impressive improvement in terms of increased turnover, also beating other sectors in that regard. Turnover amounted to 241.3 billion euros, i.e. 64.1% higher than previously. Net profits rose by 68.3%. The industry held the highest shares in Croatia (53.8%) and the Czech Republic (40.7%), where it dominates the largest players on the local market. Many utilities & public services companies are state-owned or have state involvement somewhere in their ownership structure. The largest companies in this sector can be found in Poland and the Czech Republic. The top 10 places in the ranking include two of these companies: Czech RWE and Polish PGE.

#### **Automotive & transport**

Although automotive & transport remains in the top, the sector has been struggling in recent years. There has a been a mix of factors behind this. Having suffered a steep drop in demand when the pandemic started in 2020, it then began its recovery process, which drove prices higher and led to input shortages as other sectors started improving. Supply chain disruptions had a critical impact on the sector's supply side, which suffered further in 2022 when the availability of various components decreased even further. In the European Union, sales of new passenger cars fell by 4.6% in 2022, mostly due to supply constraints. As There are 3 representatives from the sector in the top 10 of the a result, the sector was unable to record revenues in line with its potential. There are 72 companies (14.4% of the total) from the automotive & transport sector in the current ranking, i.e. 5 fewer than previously. This is even despite ten new entries to the ranking. 50 companies from the sector moved down in the ranking. The turnover of automotive & transport companies

increased by 18.3%, which was below the overall average, while net profits soared by 22.7%, which was still lower than overall growth of 46.5%.

The industry remains dominant in four countries included in this ranking with high shares in all companies: Slovakia (22.6%), Hungary (18.5%), Romania (18.3%) and the Czech Republic (18.2%). In Slovakia, the sector's share of turnover demonstrated an even stronger influence (36.9%). The average @rating score is the highest for companies in Serbia (7.0) and Romania (7.0) and the lowest in Estonia (5.0) and Lithuania (5.0), leaving the industry with an average value of 6.0.

#### Further down the sector ranking

CEE TOP 500 COMPANIES

Non-specialised trade moved down to fourth position in the current ranking and is represented by 66 companies, i.e. 10 fewer than the year before, making it the largest drop among all sectors. Poland, the biggest consumer market in the CEE region, is home to the sector's largest player: retailer Jeronimo Martins Polska. Despite accelerating inflation, household consumption was resilient, at least in the first few months of 2022. Turnover at the largest businesses in the industry rose to 129 billion euros (+19.3%), while companies were also able to record higher net profits (+11.1%). The average @rating score is 6.2, with the weakest companies based in the Czech Republic and the strongest ones located in Estonia (8.0).

Despite consumers not completely cutting spending in the course of 2022, they did reduce purchases of durable goods. Therefore, the sector of electronics, information & telecommunications suffered from a progressively deteriorating economic situation. The number of ICT companies in the ranking decreased by five entities, reaching 61 companies in total; their aggregated turnover grew by 14.7% to 104 billion euros in 2022. Net profits dropped by 24.8%, making this the largest decrease among all sectors. The Coface average @rating score amounted to 6.1

The major industries covered so far represent almost 3/4 of all ranked companies and 78.1% of the aggregated revenues, highlighting their importance in the region. Nevertheless, the smaller sectors also underwent some very interesting developments in 2022.


The 6th-ranked sector of agriculture, meat, agri-food & wines contributed 47 businesses, the same as the year before, but only 5.5% of total turnover, although this increased by a solid 27.0%. Moreover, the sector generated net profits that were up by 94.6%. Poland and Romania are home to the sector's largest companies.

The next position in the current ranking belongs to the metals sector with 18 companies, i.e. three more than previously. Turnover jumped by 25.8% to reach 35.3 billion euros, while net profits decreased by 17%. Turnover growth in the smallest sector (2 companies and 5.4 billion euros of revenue) of textiles, leather & clothing grew by 15.9%. In contrast to turnover growth, net profits slumped by 14.7%.

The best rated industry in the CEE Top 500 is very small one. Wood & furniture has only five representatives (the same as previously) in the ranking, but these companies have a very sound financial basis and an average assessment score of 8.5. The sector recorded turnover growth of 37.5%, while net profits soared by 51.1%.

Utilities & public services sector moved up from fourth to second place in Sector Ranking.





### **EMPLOYMENT AND** THE LABOUR MARKET **IN CEE**

The largest companies have been very important employers in the region. The labour market in CEE remains strained and it is still difficult to hire qualified staff. Companies in the CEE Top 500 were able to increase total staff numbers by 3.5% in 2022.

Despite the challenges and an ongoing economic slowdown, the labour market in CEE remained favourable for employees. The Czech Republic again reported the lowest unemployment rate of just 2.2% according to the Eurostat methodology. Poland came closest to this with 2.9% in 2022, followed by Hungary and Slovenia (3.6% and 4.0% respectively). Poland and Romania are also the countries that contributed the largest workforce in the In 2022, the CEE labour market was characterised by similar region with 15 and 8 million people respectively. Unemployment remained below the EU average (6.2%) in most of the CEE countries in 2022. Latvia, Croatia and Serbia recorded higher unemployment rates than the EU average.


Once again, it was the countries in southern Eastern Europe where unemployment reached the highest levels in the region. The Balkans have had very high unemployment rates in the past, which have fallen significantly over the last few years. Serbia reached a single-digit unemployment rate of 9.4% in 2022.

developments as in previous years. Labour shortages were again reported by a rising number of companies as a barrier to their business operations in many CEE countries. It is still difficult to hire qualified staff, while nominal wage growth is lively.

#### The CEE Top 500 as employers

The largest companies in CEE increased their total headcount by 3.5% to 2.3 million in 2022. Or to put it another way: 4.8% of the total CEE labour force works for one of them, which is 0.3 percentage point higher than in 2021, confirming how important these players are for the labour market in CEE.

**Lithuania** remains at the top of the list when it comes to the total percentage of the labour force employed by the largest companies in the country (10.8%), followed by Poland (8.0%) and Hungary (5.4%). A decline in employment at the largest companies was reported in six countries, with the highest decreases in the Czech Republic and Romania (by 1.5 and 0.9 percentage points, respectively). The remaining six posted increases, which further highlighted their position as important employers in the region. Those included Poland (+2.0 percentage points) and Estonia (+1.9 percentage points) in particular.

Focusing in on the figures, Poland is home to both the largest population and consequently the largest workforce in the region. However, more than 52% of all Top 500 employees work for Polish companies, whereas only 33% of all companies are Polish. Hungary comes in second, but still lags far behind with only 11.3% of all Top 500 staff, followed by Romania (11.3%) and



the Czech Republic (7.8%). The largest employers in the region are Polish companies: retailer Jeronimo Martins Polska (ranked 6th, 78,000 people), Poczta Polska (ranked 200th, 66,000) and Orlen (ranked 1st, 64,000).


One of the reasons for the high proportion of employees at Polish companies is the large share of Polish retailers listed in the final Top 500 ranking. The retail sector requires a lot of staff to keep it going. The non-specialised trade sector increased its workforce by 1.2% in 2022 and employed a total of 0.5 million (23.4%) in 2022, making it the largest industry within the ranking in terms of employees. Minerals, chemicals, petroleum, plastics & pharma employed 16.7% (+8.8%) of total Top 500 staff had the second-largest staff base within the CEE Top 500 ranking, followed by automotive & transport (16.1%), which recruited 0.6% fewer employees. The top 5 largest industries employed 78% of the total Top 500 staff in 2022.


The last sector with a double-digit share of employment in the CEE Top 500 remains ICT, which provides employment for 13.0%. The sector increased its workforce by 4.7%.

4 out of 13 sectors experienced a decrease in their staff base last year. Apart from automotive & transport as mentioned above, lower employment was recorded mostly by the textile sector (-10.8%). In contrast, the agri-food sector (+13.2%) led staffing recruitments in 2022.

### **METHODOLOGY**

The CEE Top 500 is a joint project by the Coface offices in Central Europe. This ranking covers the largest companies in the region - based on the turnover for the 2022 calendar year - and was prepared in 2022 for the fourteenth time. The study includes the following countries:

Bulgaria · Croatia · Czech Republic · Estonia · Hungary · Latvia · Lithuania · Poland · Romania · Serbia · Slovakia · Slovenia

The largest companies in each of the above countries (turnover ≥ EUR 300 millions) were identified, excluding financial service providers such as banks, insurance companies, leasing firms and brokers. In addition to revenues, the CEE Top 500 study includes other key corporate indicators, e.g. net profits, the number of employees and the respective changes in relation to the previous

Turnover and profit were converted into EUR based on the exchange rate at the end of 2022. The data were taken from our Coface **iCON** database and supplemented with external information as required.

The ranking does not include companies that refused to provide financial results by the time the CEE Top 500 list was finalised.




Chart 6: Credit Risk distribution of CEETOP500 companies

The year 2022 brought continued economic expansion in the CEE region. Admittedly, growth rates did not reach levels as high as in the 2021 pandemic recovery, although economic activity was still solid. Indeed, average GDP growth for CEE reached 4.0% in 2022, having recorded 6.2% in 2021. That came as a surprise, as CEE economies were expected to suffer promptly when the full-scale Russian invasion of Ukraine started in late February 2022 due to the region's geographical proximity and trade links. However, CEE resilience kept its economies growing. Only Estonia recorded a mild recession of 0.5% while growth rates in other countries were close to their potential, with the highest expansion recorded by Poland (+5.3%) and Croatia (+6.2%). The latter was able to attract lots of tourists again as it rebounded from the deep slump it experienced during the pandemic lockdowns.

Nevertheless, solid economic activity hides details that not only helped to deliver growth rates, but were also challenges for the CEE region. Rising inflation was an important topic that promptly had a dampening effect on consumer spending and confidence. Inflation rates started growing in late 2021 and continued to do so throughout 2022, reaching highs not seen since the collapse of communism in CEE countries. Indeed, the region's economies already had high inflation at the beginning of 2022, although it still in the single-digit range, before soaring to even above 20% in the Baltics and Hungary in late 2022. Accelerating inflation was caused by several factors. In 2022, the prices of energy commodities continued to increase and were further elevated when Russia launched its full-scale invasion of Ukraine. Although prices of crude oil started to decrease in mid-2022, they remained higher than in previous years, while natural gas quotations soared due to Europe's high dependence on Russian sources. Furthermore, the pandemic recovery triggered supply chain disruptions that limited the availability of various components and parts used in the manufacturing process, with prices surging. As with energy commodities, the war in Ukraine was another reason for further price increases and lower availability of various components, as both Russia and Ukraine were significant global producers and exporters of metals used by a number of sectors.

On the other hand, this macroeconomic environment enabled companies to record growing turnover and pass rising costs on to final consumers. Of course, it was impossible to pass on all of these higher costs, which included

not only energy and component prices, but also further increases in labour costs. Indeed, despite all the challenges of 2022 and the preceding years, the labour market in the CEE region remained tight. Unemployment levels were relatively low and close to their all-time lows, nominal wage growth remain solid, also supported by continued increases in minimum wages, while companies still had to cope with labour shortages. That also explains the region's economic resilience in the course of the war in Ukraine, which borders a number of CEE countries. Higher inflation than in Western Europe is another factor. Improvements in the CEE labour market began in 2023, which resulted in a gradual rise in inflationary pressures. A high dependence of several countries on Russian energy commodities as well as a higher share of food in inflation baskets explains why the region grew more than Western European countries.

CEE countries continued to be active exporters. The main destination remained Western Europe, although they have also been exploring locations further afield, thanks to direct shipments and the inclusion in various supply chains. Looking into 2023 and beyond, the external situation became the main risk for the CEE region. Western Europe is experiencing weak economic activity, including a struggling Germany, which remains the main export destination for the CEE region. That includes not only domestic demand, but also subdued global trade which affects CEE countries as a result. Low levels of industrial production, new orders and business sentiment indicate that a prompt and strong recovery is not a baseline scenario. Nevertheless, each successive quarter should bring a gradual improvement and the CEE region is expected to record higher growth rates as a result. At the same time, household consumption lost its resilience and retail sales in CEE countries dropped into negative annual dynamics as high inflation and increased interest rates have taken an increasing toll on the economy. However, as the disinflation process progresses and the labour market remains strong, household consumption should gradually deliver an increasing contribution to growth. If the external situation also improves then the path to recovery would be open and CEE countries could again record growth rates in line with their potential. Nevertheless, the business liquidity situation will be affected by challenges. Companies insolvencies are already on the rise as support measures are terminated and the macroeconomic deterioration exceeds pre-pandemic levels.
